# HOW IT WORKS

## Lease Inception

Customer purchases Excess Wear & Use Protection at lease inception

## Lease Term

Damage, wear and tear may occur

## Lease-end

- An independent inspection is performed
- Customer returns vehicle to dealer
- Lessor waives qualifying charges
- Customer receives final, adjusted statement



# PROTECTION

- Total Waiver Limit: \$7,500
- Each single event valued at \$1,000 or less
- Each missing part or equipment valued at \$150 or less
- Key and/or fob valued at \$400 or less
- Windshield replacement/damage
  - o up to \$600 for cars
  - o up to \$700 for SUVs

# ELIGIBILITY

- Mitsubishi Motor Sales of Canada leases (available at lease inception only, with lease terms up to 60 months)†
- New Mitsubishi vehicles and untitled demonstrators with 24,000 or fewer kilometres leased through Mitsubishi Motor Sales of Canada
